Position Title: Facilities Land and Maintenance Technician

Reports To: Tribal Administrator
Department: Tribal Facilities

FLSA Status: Full-Time: Non-Exempt

Salary Grade: \$12-\$18/hr.

POSITION SUMMARY:

The Facilities Land and Maintenance Technician provides general maintenance services on all tribal lands within the territory and jurisdiction of the tribe. Services will include routine building and facility maintenance, land maintenance including weed eating, brush clearing, fencing, general clean-up and other tasks as assigned.

DUTIES AND RESPONSIBILITIES:

- Inspect buildings and other facilities and structures to determine necessary repairs.
- Perform minor electrical maintenance to include, but not limited to, replacement or repair of fixtures (e.g. wall switches and outlets, light bulbs and tubes, ballast, minor appliances, etc.).
- Perform minor plumbing maintenance (e.g. replace or repair leaks in drains and faucets, unclogging of drains, trenching and laying new lines, etc.).
- Perform minor painting, carpentry and masonry work (e.g. preparing surfaces and using brush, sprayer or roller to apply paints, stains and varnishes, hanging doors, fitting locks and handles, etc.).
- Weed eating, mowing and other landscape maintenance around Tribal facilities and on Tribally owned land, including maintenance and repair of related structures such as fountains and ponds.
- Clearing brush and fallen trees as necessary to maintain safety and firebreaks around Tribal lands, buildings and other facilities.
- Order necessary parts and maintain required documents.
- Perform other related duties as assigned.

OTHER REQUIREMENTS:

- Must be able to work flexible hours and be a self-starter.
- Ability to work indoors and outdoors in all weather conditions.
- Knowledge and proper use of various common tools and other equipment including lawn mower, weed eater, chainsaw, miscellaneous power and hand tools, and two-way radio.
- Perform heavy manual labor, including the ability to push at least 100 pounds and ability to lift at least 50 pounds.
- Bending at the waist, sitting, kneeling, laying horizontally, climbing, walking, etc., as job may require.
- Must successfully pass a pre-employment drug/alcohol screen and background investigation.
